



Parking Declaration & Terms and Conditions

1. I acknowledge that this application is for a parking permit to authorise the parking of my vehicle(s) in the respect of which it is issued on the Metropolitan Hospital Site where parking requires a permit.
2. The issue of the permit is not for the provision of parking and I understand that parking may not be available to me.
3. I understand that the permit issued to me is for my use only and can only be transferred between my vehicles.
4. The Metropolitan Access and Parking Department (MAPD) accept no liability for the loss or damage to vehicles parked in any car park operated and managed by the MAPD.
5. I agree to inform the MAPD of any changes to the information provided on this application. I understand that failure to inform the MAPD may result in my parking privileges and permit being revoked.
6. I understand that the applicable fees as detailed on the Metropolitan Access and Parking Strategy Website are payable from the date my parking application is approved. Unless payment is made in full at the time of authorisation.
7. I understand that the MAPD reserves the right to withdraw my parking privileges / permit or change my allocated parking area at anytime.
8. I understand that an administration fee will be charged to replace a lost permit / access card.
9. Refunds will not be made if any changes in circumstances are not reported to the MAPD i.e. sale or transfer of vehicle.
10. I understand that the information provided on this form will be subject to validation by my Head of Department/Service.
11. I understand that if this form has not been completed fully, it will not be considered for the application process.
12. I understand that, should I knowingly and deliberately make a false statement / false certification, I will be liable for disqualification from the allocation process and my parking privileges / permit will be revoked.
13. I have read the above and agree to abide by the conditions as set out by the MAPD.

Conditions of Entry and Limitation of Liability

1. You enter and use this car park at your own risk.
2. The Hospital Sites or the MAPD is not liable for you or any person with you for:
 - o • Injury to you or anybody else;
 - o • damage to, destruction of, theft or unauthorised delivery up of your vehicle or any other vehicle whether authorised or not; or
 - o • damage to, destruction of, theft of or delivery up of any property (including anything in or on your vehicle or any other vehicle); however caused, and you realise and indemnify us from any claim, which you might otherwise have against the hospital sites or MAPD.
3. You agree to indemnify the Hospital Sites or the MAPD in respect of any claim made against Hospital Sites or the MAPD as a consequence of, in relation to, or in any way arising out of the use of this car park.
4. Hospital Sites or the MAPD will not be liable to you for delivery of your vehicle to any person who did not have authority to take your vehicle.
5. Infringement notices distributed for illegal parking in designated parking areas are enforceable under the regulations that form part of the 'Health Services (Conduct and Traffic) Regulations 2016'.
6. Parking fees are applicable under the regulations that form part of the 'Health Services (Conduct and Traffic) Regulations 2016'. Entry to the car parks is taken as your agreement to the regulations and applicable fees.
7. You agree to:
 - o Produce and display when requested by an authorised person your parking permit or ticket as and where required proof of payment of the parking fee;
 - o Not to cause any obstruction;
 - o Not to park anywhere that is designated as a no parking area;
 - o Not to use this car park other than in accordance with instructions that an authorised person may give;
 - o Comply with all reasonable directions and requests made by an authorised person.
8. If any of these conditions are illegal or unenforceable, the offending part is to be disregarded and does not affect the remaining part.
