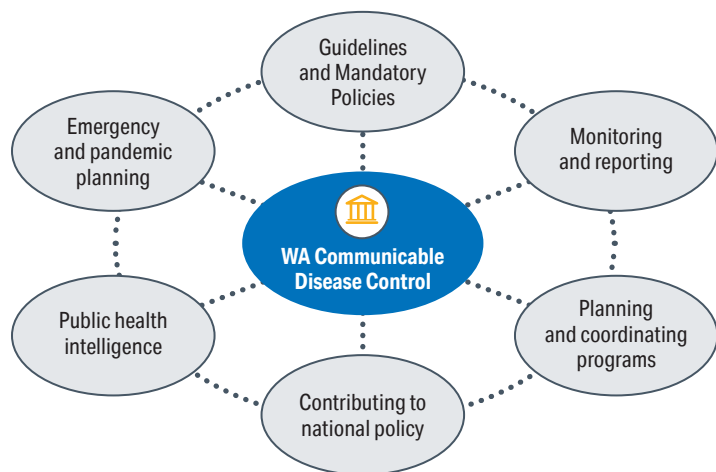
Planning context

The **Communicable Disease Control Directorate (CDCD)**, is part of the Public and Aboriginal Health Division of the Western Australian (WA) Department of Health. CDCD develops and maintains multiple guidelines and Mandatory Policies, guided by the high-level strategic directions of the *State Public Health Plan for Western Australia 2019–24*.

The legislative environment within which CDCD operates is framed by the *Public Health Act 2016* and *Public Health Regulations 2017*, and the *Health Services Act 2016*.

Other guiding documents include the *WA Immunisation Strategy*, *Infectious Disease Emergency Management Plan* and *WA Sexual Health and Blood-borne Virus Strategies*.
