

High Risk Medication Management Policy Compliance Audit Tool

Introduction

Medicines and Technology Unit are responsible for monitoring Health Service Providers compliance to the mandated requirements of MP 0131/20 High Risk Medication Management Policy. This policy mandates the minimum requirements for the safe management of high risk medications, while upholding the principles of clinical governance under the Health Services Act 2016.

This Compliance Audit Tool supports Health Service Providers in the collection of required data used to evaluate the compliance of MP 0131/20 High Risk Medication Management Policy.

Instructions for completing the Compliance Audit Tool

All Health Service Providers managing high risk medications must undertake ongoing audit and evaluation to ensure adherence to MP 0131/20 High Risk Medication Management Policy and monitor outcomes of compliance with this policy.

This audit tool must be completed annually by the Health Service's Medication Safety Governance Group, Medicine and Therapeutics Committee, or equivalent committee. Once completed, it must be submitted to the Medicines and Technology Unit via REDCap® [https://redcap.link/wahrmaudit] by 28 February each year.
