



Smoke Free Policy

1. Purpose

The *Smoke Free Policy* (policy) requires that all WA health sites are smoke-free and vape-free. This includes, but is not limited to, all owned or leased buildings, structures, outdoor areas, grounds, car parks and vehicles.

The purpose of the policy is to:

- protect and prevent health risks for all WA health employees, consumers, contractors and visitors to WA health sites by eliminating potential exposure to second-hand smoke and e-cigarette (vape) aerosol; and
- lead by example by delivering a clear message to the community and other government agencies that all WA health sites are smoke-free and vape-free.

Under the *Work Health and Safety (General) Regulations 2022*, smoking is not permitted in enclosed workplaces.

The policy is consistent with the following legislation:

- *Tobacco Products Control Act 2006*
- *Work Health and Safety Act 2020 (WA)*.

The policy is also consistent with the:

This policy is a mandatory requirement for Health Service Providers under the *Public Health Policy Framework* pursuant to section 26(2)(l) of the *Health Services Act 2016*.

This policy is a mandatory requirement for the Department of Health pursuant to section 29 of the *Public Sector Management Act 1994*.

2. Applicability

This policy is applicable to WA health entities.

The requirements contained within this policy are applicable to the services purchased from contracted health entities where it is explicitly stated in the contract between the contracted health entity and the State of Western Australia or Health Service Provider. The State of Western Australia or Health Service Provider contract manager is responsible for

ensuring that any obligation to comply with this policy by the contracted health entity is accurately reflected in the relevant contract and managed accordingly.

3. Policy Requirements

To ensure smoking is not permitted (including use of tobacco products, electronic cigarettes (vapes) and other related products) in any owned or leased buildings, structures, outdoor areas, grounds, car parks or vehicles, WA health entities must have local procedures in place to meet the following requirements:

1. Implement site-specific management and compliance strategies.
2. Implement site-specific communication strategies to ensure that anyone entering the premise understands that smoking and vaping is not permitted.
3. Complete the [Smoke Free Policy Annual Reporting Form](#).

In addition to the above, Health Service Providers that provide inpatient services must have local procedures in place to meet the following requirements:

4. Provide employees with access to nicotine replacement therapy (NRT) listed on the Australian Register of Therapeutic Goods.
5. Assess and record the smoking and vaping status of all inpatients aged 16 years and over.
6. Provide treatment for nicotine dependent inpatients.

4. Compliance Monitoring

The Population and Preventive Health Directorate, on behalf of the System Manager, will monitor compliance with this policy. WA health entities must report the following information (for the period 1 July to 30 June) using the [Smoke Free Policy Annual Reporting Form](#) by 14 August, on an annual basis:

- management and compliance strategies implemented
- communication strategies implemented
- local procedures to provide staff members access to NRT
- local procedures to assess and record smoking and vaping status of all inpatients aged 16 years and over
- local procedures to provide treatment for nicotine dependent inpatients
- any reported issues with local implementation and compliance.

The System Manager may also request additional information, including data and documents associated with local procedures, to ensure alignment with policy requirements.
