Current and future impacts and risks to health from climate change, including worst case scenarios, 'unthinkable events', and high-end risks.

- My community in Toodyay already has to deal with hotter summers and cold winters and a drying climate. Bushfires are intensifying.
- The river level is lower, but extreme weather events could lead to more regular flooding of parts of Toodyay.
- Our nearest hospital is Northam, a 20 min drive.
- We have quite an elderly community, they are at risk of heat stroke
- We are surrounded by forests, we are very much in danger already by out of control bush fires.
- the main road to Perth is for a large part surrounded by dry forest. So is the train line. This is a risk.
- we don't produce much of our own energy in Toodyay, most of our energy comes from the SW connected grid. This is a risk if we get cut off.
- I am unclear where our drinking water comes from, apart from water tanks at the top of the hill. River, rain, piped from Perth? This in itself worries me.
- Our food is already more expensive than Perth, especially fresh produce. We have farms in the area, but they don't cover all our needs.
- air pollution in the valleys from people's fireplaces/woodstoves in winter is a health issue.

- I am concerned about my own mental health, and that of others, as the risks increase. Already, I am very anxious every time I smell or see smoke from my house, and I live in the town site!

Define the role of the Department of Health in leading public policy on climate change and health;

- the DoH needs to be talking more about climate, talking about the multitude of issues of a changing climate, but also the direct impacts of emissions from coal, gas, burning diesel and wood(or waste incineration!), on air pollution.

- need to talk about the costs, economically, of not acting now. It will cost more in the long run to mitigate, and deal with the costs to health. A bit like not dealing with asbestos or tobacco. Industry can not be part of setting policy on this stuff!! Why would they even be 'consulted'. We, our government, need to be telling them what to do.

The WA Government as a whole need to make stronger climate change policy. The recent 2050 target is a great step forward, but nowhere near enough. We need yearly targets, that have to be met. We need to be reducing our emissions, not increasing them (offshore and onshore gas!!!).

We need a stop to all NEW fossil fuel projects, including onshore unconventional gasfields across the state.

Renewables, carbon farming, (regenerative) agriculture, tourism, should be the main parts of our regional economies.
