Leadership and communication are key to risk mitigation and adaptation of community to climate issues

Overarching leadership at all levels of government is required to enable the action required to support global efforts on climate change including IPCC and Paris Agreement. Western Australia provides a unique opportunity to be forerunners in leadership by communicating with all ministerial portfolios, be enduring and bipartisan. Strategies to build climate mitigation and adaptation strategies need to be cross sectorial and implemented at an individual, community and system level. State governments have a responsibility, to their residents, to implement a range of cohesive and coherent policies across a range of climate drivers including the food system, education, transport and town planning as this will affect the place in which people live and work and the place in which their children will live and work, today's decision making needs to protect the Western Australian community for future generations. WA DOH can be innovators and change champions to increase community awareness of required climate change actions related to health.

change. This needs to be supported with a monitoring strategy and build in levels of accountability with defined timelines to ensure actions are achieved in a timely manner.

WA DOH to promote use of consistent communication and messaging to profile/promote local health initiatives that reduce waste, support local initiatives, for example, the keep cup, urban farming at a commercial and individual scale, grey water.

WA DOH to work with ECU to develop online short courses for community groups, community leaders, volunteers, CEO of the food retail sector to educate about the food system and health implications with a focus on climate.

WA DOH set up a register of local climate initiatives that can be supported by volunteers –from universities, schools, retail groups, community groups, to undertake GHG offset actions - use volunteer workforce – to be the change agents, through media platforms to increase reach.

WA DOH to support wider dissemination of climate and health information and impacts to all sectors to drive policy awareness, implementation, monitoring and evaluation.

WA DOH to guide LGA how to strategically catalyse required change.

WA DOH to support collation of LGA activities (captured through monitoring) to feedback to federal government as part of SDG reporting

WA DOH to have strong internal climate change mitigation and adaption policies spread across all departments, that incorporate implementation strategies and accountability processes to model the change that is required.
