WHAT ARE THE BURNING ISSUES

From a large number of identified concerns, the following burning issues stood out:

- Lack of strategic direction in health for a region in transition where the rate of growth has outstripped health service delivery
- Expectations that local health needs will be delivered locally and without travel to Perth
- Local hospital capacity issues including lack of access to beds, limitations on the Emergency Department, limited access to specialities such as paediatrics, and limited cancer treatment facilities and options
- The need for better support for mental health services including GPs who will support mental health patients, a lack of mental health triage in emergency situations and mental health

support in outlying areas

- Issues around the lack of nursing home beds, staffing in aged care facilities and the need for better aged care training in the region
- Lack of coordination in the transfer of care, with information not shared electronically, poor connection to after-care and follow-up and a lack of knowledge about services that are available locally
- Lack of focus on prevention beyond schools, and on the high chronic disease profile and the linkages with obesity, eating disorders and socio-economic disadvantage
- The need for increased post rehabilitation support for people affected by drug use

THE CRITICAL CONVERSATIONS THAT WE MUST HAVE

- Better transfer and coordination of care and support
- Better use of technology to enhance integrated service delivery
- A Health Plan for the region that clearly defines the services delivery needed for a region in transition
- Addressing the underlying issues for mental health and developing longer term support options
- Clarity of policy and programs around prevention and individual responsibility for health





SUGGESTIONS FOR LONGER TERM PLANNING AND PARTNERSHIPS, GIVEN THE CHANGING DEMOGRAPHICS OF THE PEEL REGION

- Give Peel status as a standalone health zone within the region
- Develop the infrastructure and services required to support a rapidly growing population, which means significant enhancement of the Peel Health Campus as a regional hospital
- Develop a consolidated Health Plan to build value from the existing health services and facilities within the region
- Take advantage of the big opportunities for increased Local Government roles in health planning, promotion and delivery, via Community Resource Centres
- Trial innovative options for village based, aged care such as intergenerational facilities that co-locate aged care and child

care

SUGGESTIONS TO IMPROVE COORDINATION AND SEAMLESS TRANSFER OF CARE

- IT solutions that feed into the My Health Record and ensure automatic transfer of information to relevant Departments, GPs and authorised services
- Telehealth services used to dramatically improve transition services
- Interchangeable activity between public and private facilities where care is not available locally in one system
- Expand the Wheatbelt Health Navigator model
- Planned and coordinated follow-up through technology, phone and assigned visit

SUGGESTIONS ON THE USE OF TECHNOLOGY To support patient pathways

- Use of the Medicare number to provide access to electronic health record apps in any situation
- Increase Telehealth and Telemedicine to include doctor's surgeries
- Statewide planning for increased Telehealth and Telemedicine
- Use of Health Pathways by GPs to get consistency of care





SUGGESTIONS FOR ADDRESSING THE UNDERLYING ISSUES IN THIS REGION Which impact mental health

- Improve the youth triage options at Peel Hospital
- Create mental health observation areas to ensure better safety for all in ED situations
- Create clinic services for obesity and eating disorders in the region, to address underlying links to better mental health
- Begin education and awareness in early learning centres and primary schools
- Improve access to services, especially for smaller communities
